



# SEN+D Reforms Newsletter

#### Information Updates

We would like to share with you regular Newsletters to keep everyone up-to-date with developments and give as many people as possible the opportunity to be part of the change ahead. Please share this newsletter far and wide to colleagues and families.

The SEND Reforms set out in the Children & Families Bill, for all children and young people who have a special educational need and disability (SEND) are;

- i. Extending the SEN system from birth to 25, giving children, young people and their parents/carers greater control and choice in decisions about provision
- ii. Replacing statements and learning difficulty assessments with a new birth to-25 Education, Health and Care (EHC) Plan
- iii. Offering families the option of personal budgets when an EHC plan is implemented
- iv. Improving cooperation between all the services and requiring particularly local authorities and health authorities to work together
- v. Requiring LAs to involve children, young people and parents in reviewing and developing provision for those with special educational needs and to publish a 'local offer' of support
- vi. Publication of a new SEN Code of Practice and regulations covering the work of early years providers, schools and post-16 education providers, Local Authorities (LAs) and Health Authorities.

#### **Children and Families Bill 2014**

As you may know the Queen signed her name on the dotted line last Thursday 13<sup>th</sup> March, 2014 and the Children and Families Bill received Royal Assent. Children and Families ACT

There are a few particular clauses in it applying to personal budgets and direct payments however most of the key information will form part of the regulations (the next step) and then the Code.

#### **Children and Young People Engagement**

Work is taking place with the voluntary organisation Action for Children and Lincolnshire's Shadow Transition Board, a group of young people aged between 14-25yrs with a range of special educational needs, the School Improvement Team and Educational Psychologists Team to ensure we are engaging as much as possible with as many children as possible countywide.

## Education, Health and Care Plan (EHC Plan)

15 families have been identified to take part in the first trial of the EHC Plan (link given below). They have been randomly selected from the database of existing statements and checked to ensure all ages and complexity of need are covered. These families will be contacted by a key worker known to them to gain their consent. A further trial will take place once feedback has been received from the initial group.

#### **SEN Local Offer**

Through research done by Lincolnshire Parent Carer Council with parents and the evidence gathered from National SEN+D Pathfinder Authorities, Lincolnshire decided to commission a company called Open Objects to support our Web-based SEN Local Offer

The first view of this will be available on-line 28<sup>th</sup> April 2014. Each school must also have their own school's Local Offer available on their school site. Workshops are taking place to support the expectations of the School's Local Offers.
